## Purpose

As a Magnet Engineer, you will support the Technical Responsible Officer for Central Solenoid (CS) and Poloidal Field (PF) coils to assess the coil design and performance. As part of the construction team, you will assess the procedure to perform the on-site assembly, develop and qualify as needed corrected actions, supervise construction activities under the CS and PF coil assembly scope.

## Background

The ITER magnet system consists of 4 main magnet systems, the Toroidal Field (TF) coils, the Poloidal Field (PF) coils, the Correction Coils (CC) and the Central Solenoid (CS) coils. The CS is a stack of 6 coil modules at the center of the machine, using Nb3Sn superconductor operating at fields up to 13T and with a total weight of 1000t.

## Major Duties/Roles & Responsibilities

- Follows-up CS and PF coil manufacture:
  - Review technical documentation as requested;
  - Develop recovery plan to solve issues;
  - Follows up work under the Procurement Arrangement with Domestic Agency and their suppliers.
- Reviews deviation requests and Non-Conformance Reports, and provides performance impact predictions (structural, superconducting, electrical);

- Performs procedure preparations and assessment related to the insertion of the CS stack and the CS coil modules, PF coils installation by contractors, the preparation and qualification of special assembly procedures and drawings, the preparation of the Engineering Work Package and handing over to the contractors;
- Follows up the on-site stacking of the CS and the PF coils assembly, especially for quality monitoring and supervision of special processes;
- Ensures the CS and PF coil performance is maintained during ongoing testing and verification, based on the design assumptions and criteria, and implements corrective actions if needed;
- Provides assembly options to mitigate technical and schedule risk for the CS, PF and CC assembly phase;
- Supports interfaces between the CS coil/structure system and power supplies, cryoplant, feeders, instrumentation, vacuum as well as the construction organization;
- May be requested to be part of any of the project/construction teams and to perform other duties in support of the project;
- May be required to work outside ITER Organization reference working hours, including nights, weekends and public holidays.

## Measure of Effectiveness

- Monitors efficiently the procurement activities as per the ITER quality, cost and schedule requirements for delivery, as well as meeting intermediate ITER milestones;
- Maintains the performance requirements of the CS & PF coil systems;
- Identifies interfaces efficiently and minimize any impact on schedule or cost related to their management;
- Meets the construction schedule requirements for CS & PF coils on-site;
- Meets the quality requirements for the CS & PF systems for the recording of manufacturing data, non-conformances and deviation requests.

## Experience & Profile

- **Professional Experience:**
  - At least 5 years' experience working as mechanical engineer, managing superconducting coil and conductor mechanical assemblies, mechanical analysis, testing, manufacturing.
- **Education:**
  - Master Degree or equivalent in an Mechanical Engineering field or other relevant discipline;
  - The required education degree may be substituted by extensive professional experience involving similar work responsibilities and/or additional training certificates in relevant domains.
- **Language requirements:**
  - Fluent in English (written and spoken).
- **Technical Competencies and Demonstrated Experience in:**
  - Providing superconductor competencies in the field of superconducting magnets (with a good record of publications in respected journals being an advantage);
  - Supporting the analysis of complex and challenging technical issues or problems, proposing solutions;

  - Planning verification of compliance of the products with all applicable requirements and formulating and executing recovery plans;
  - Using Catia or similar 3D engineering software.
